

## **THE CABINET OF THE VIRGIN ISLANDS - POST MEETING STATEMENT**

### **CABINET DECISION**

18<sup>th</sup> January, 2023

#### **Cabinet Meeting – 18<sup>th</sup> January, 2023**

His Excellency, the Governor Mr. John J. Rankin, CMG, chaired the Meeting held on 18<sup>th</sup> January, 2023 at the Premier's Conference Room, Cutlass Tower.

All Members were present, with the exception of the Premier and Minister of Finance Dr. the Hon. Natalio Wheatley, who was on duty travel.

Cabinet:

1. Decided:
  - a. that, in accordance with the provisions of Section 5 of the Financial Services Commission Act, 2001, the following persons be reappointed to the Financial Services Commission's Board of Commissioners:
    - i. Robin Gaul - Chairman for one (1) year, upon the completion of his current term from 6<sup>th</sup> February, 2023 to 5<sup>th</sup> February, 2024;
    - ii. William Gilmore - External Commissioner and Member for two (2) years from 14<sup>th</sup> December 2022 to 13<sup>th</sup> November, 2024); and
    - iii. Johanna Boyd - Member for two (2) years from 14<sup>th</sup> December, 2022 to 13<sup>th</sup> November, 2024)
  - b. that the Ministry of Finance instruct the Attorney General's Chambers to prepare the Instruments of Appointment and thereafter published in the Official Gazette.
2. Decided that Mr. Brodrick Penn be appointed as a member representing employed persons and Deputy Chairman of the Social Security Board in accordance with Schedule 6(1) of the Social Security (Amendment) 2014, for a period of three (3) years with effect from 15<sup>th</sup> January, 2023; and noted that the Deputy Chairman will be remunerated from the Social Security Fund in the amount of one thousand dollars (\$1,000) per month in accordance with section 6 of the Social Security Ordinance (Cap. 266).

3. Approved one (1) Non-Belongers Land Holding Licence application and an application for a Grant of Easement over crown land property.
