2. **I agree**, that my tent size must be a minimum of 10 feet by 10 feet or a maximum of 15 feet by 15 feet.
3. **I agree**, to decorate my stall appropriately to make the Cultural Fair appear as festive and tasteful as possible and that no advertising materials or stickers from any business are to be displayed on my stall.
4. **I agree**, that my stall will be used only for the sale of the stated and agreed items.
5. **I agree**, to comply and follow the rules as stipulated by the Department of Environmental Health before, during, and after the opening of my stall.
6. **I agree**, that all persons handling food and drinks must obtain a valid food handler's permit from the Department of Environmental Health. All persons handling food must be properly dressed and observe all rules to reduce contamination of food and drink as per the guidelines of the Department.
7. **I agree**, not to sell or serve drinks of any kind in glass bottles or cans but to pour all drinks into plastic cups.
8. **I agree**, to provide the Cultural Food Fair Sub-Committee Chairperson with a copy of a valid food handler's certificate for all persons preparing, handling and serving food and drinks from my stall.
9. **I agree**, that I must leave the premises where my stall was erected free from any and all debris including but not limited to paper, containers, packing material, food items, utensil and other sharp objects or refuse. I agree that none of these items may be left on any
