



PUBLIC TENDER NOTICE

No. 14 of 2019

The Government of the Virgin Islands (British) invites tenders for the Procurement of Works for Lot 2 – Procurement and Installation of the Sewer Network System in Cane Garden Bay, Virgin Islands (British). Funding for the Contract will be through the Government of the Virgin Islands.

SCOPE OF WORKS

The works consists of:

- The demolition and removal of 35 existing fiberglass lift station
- Procurement and Installation details of the primary project components are as follows:
 - o 1440m of 300mm dia. PVC gravity lines
 - o 306m of 200mm dia. PVC gravity lines
 - o 1902m of 100mm dia. PVC gravity lines
 - o 480m of 100mm dia. PVC force mains
 - o 180m of 150mm dia. PVC force mains
 - o 10 submersible duplex shredder pumps along with backup generators for each
 - o 25 No. 1.2 dia. Precast concrete manholes
 - o SCADA system connected to sewer network

INSTRUCTION OF TENDERERS

Tenderers are required to furnish the following:

- (a) Certificates of Good Standing in respect of Social Security and Taxes including Payroll and Property Taxes from:
 - (i) The Director of Social Security Board; and
 - (ii) The Commissioner of Inland Revenue
- (b) Trade License (valid for 2019) (if Partnership or Sole Proprietorship)
- (c) Certificates of Good Standing from Commercial Registry (if company is a registered agent)
- (d) National Health Insurance

Note: The date issue indicated on the above mentioned certificates and license should be no earlier than one month prior to the date of submission.

The bidder shall furnish a Bid Security in the amount of 1% the bid price; non-submission of Bid Security will lead to rejection of proposal.

TENDERERS MINIMUM REQUIREMENTS

- A. Minimum average annual turnover of \$1,500,000.00, calculated as total certified payments received for contracts in progress or completed within the last Five (5) years.
- B. The Bidder must demonstrate access to, or availability of, financial resources such as liquid assets, lines of credit, and other financial means other than any contractual

advance payments to meet:

- i. The following cash-flow requirement:
THREE MONTHS ESTIMATED AT \$500,000.00
and
- ii. The overall cash flow requirements for this contract and its current commitments.

- C. Experience under contracts in the role of contractor, in the role of prime contractor, JV member, sub-contractor, or management contractor for at least the last FIVE (5) years starting 1st January, 2014.
- D. A minimum number of similar contracts specified below that have been satisfactorily and substantially completed as a prime contractor, joint venture member, management contractor or sub-contractor between 1st January, 2014 and application submission deadline: (i) Five (5) contracts, each of a minimum value US \$1,000,000.00.
- E. For the above and other contracts executed during the period stipulated in D above, a minimum experience in the following key activities:
 - a. Pipe laying
 - b. Pump Installation
 - c. Roadworks
