### BVI HEALTH SERVICES AUTHORITY BOARD

The Government of the Virgin Islands is seeking qualified individuals interested in serving as members of the BVI Health Services Authority Board.

#### HEALTH SERVICES AUTHORITY BOARD

The BVI Health Services Authority ("the Authority") is a Statutory Body established under the BVI Health Services Authority Act, 2004 and falls under the portfolio of the Minister for Health and Social Development. The BVI Health Services Authority Board ("the Board") has responsibility to establish and institute policies for the efficiency, good order and effective management of the Authority.

The role of the Board is to set the strategic direction for the administration of the Dr. D. Orlando Smith Hospital and community health services, as well as to determine policies for the provision of health services based on the healthcare needs of the Territory. Among the Board's varied functions is responsibility to establish and manage programmes and services that promote, protect, and maintain good health in communities throughout the Territory, ensure continuous improvement in the quality of care provided to patients, and ensure adequate management of the Authority's resources.

The Cabinet may appoint seven to nine persons to serve on the Board on recommendation of the Minister. Two of these persons must be nominated by the Leader of the Opposition. Among those appointees, one person may be appointed as the Chairperson of the Board – after consultation with the Leader of the Opposition, and subject to the approval of the House of Assembly. Another appointee may be designated as Deputy Chairperson on recommendation of the Minister.

#### SKILLS AND COMPETENCIES REQUIRED:

Persons applying to serve on the Board must be willing to make a professional commitment to the Board in carrying out its functions; be able to attend scheduled meetings, including meetings of assigned Board committees, and make a substantial active contribution to Board deliberations. Ideal candidates should demonstrate the qualities and professional competencies that match the mandate and responsibilities of the Board, including:

- a) Highly developed skills in leadership and problem-solving;
- b) Commitment to confidentiality, integrity, and good corporate governance;
- c) Ability to think strategically, manage complexity and act decisively;
- d) Strong communication and interpersonal skills, and the ability to maintain good working relationships;
- e) Ability to exercise discretion and good judgement; and
- f) Innovation and adaptability.

#### AREAS OF EXPERTISE

Candidates must have knowledge, experience and expertise in medicine, law, accounting, nursing, insurance, social work or other professions.

Consideration will also be given to persons representing the BVI Chamber of Commerce and Hotel Association, academia and the religious community.

#### COMPENSATION:

With the exception of Public Officers, stipends are paid to members of the Board at rates determined by the House of Assembly.
